

# NOTICE OF ESTABLISHMENT OR CHANGE OF A REGULATION AFFECTING THE USE OF LAND

## JOINT PUBLIC HEARING OF THE HERNANDO COUNTY LOCAL PLANNING AGENCY AND THE HERNANDO COUNTY BOARD OF COUNTY COMMISSIONERS

**NOTICE IS HEREBY GIVEN** that a joint public hearing with the Hernando County Board of County Commissioners as the Local Planning Agency and the Board of County Commissioners will be held on Tuesday, March 8, 2022. **The meeting starts at 9:00 AM and the ordinance will be heard thereafter in the order established when the agenda is published.** The meeting is located in the John Law Ayers County Commission Chambers, Hernando County Government Center, 20 North Main Street, Room 160, Brooksville, Florida.

The Hernando County Local Planning Agency will conduct a public hearing to review the proposed land development regulations and make a determination as to whether the proposal is consistent with the adopted Hernando County Comprehensive Plan.

The Hernando County Board of County Commissioners will conduct a public hearing to consider a proposal to change a regulation affecting the use of land within Hernando County and to consider adoption of the following ordinance:

**AN ORDINANCE AMENDING CHAPTER 10 (COMMUNITY APPEARANCE), ARTICLE II (LANDSCAPING), CODE OF ORDINANCES, HERNANDO COUNTY, FLORIDA, TO PROVIDE EXEMPTIONS FROM LANDSCAPE SURETY REQUIREMENTS FOR LAND CLEARING PERMITS WHEN A BOND IS ALREADY REQUIRED BY SECTION 255.05, FLORIDA STATUTES; PROVIDING FOR SEVERABILITY; PROVIDING FOR INCLUSION IN THE CODE; PROVIDING FOR THE REPEAL OF CONFLICTING PROVISIONS; PROVIDING AN EFFECTIVE DATE.**
